WHAT IS ORGANISATIONAL AND INSTITUTIONAL STUDIES?

Organisational and Institutional Studies (OIS) is a new programme in the School of Social Sciences coordinated by the Public Affairs Research Institute. The programme offers ways to understand organisations and institutions of government and a multidisciplinary approach to the study of the state and civil society.

The study of institutions can unlock many of the central political challenges facing nations across the globe.

In South Africa, where the various approaches to studying institutions have developed unevenly, this programme brings together insights from the fields of Political Science, Sociology, Economics and Anthropology to provide in-depth observation and analysis of how institutions shape power dynamics and impact major political outcomes.

The Organisation and Institutional Studies (OIS) Honours Programme is intended for students interested in basic theoretical debates on institutions. The programme focuses on foundational texts as well as the elements of how to do research and write an essay.

The Honours Programme is made up of one theory core course—Basic Concepts in Organisational and Institutional Studies, one 10.000 words Research Essay Course—as well as electives. All students must complete 122 credits, comprising of the course in Basic Concepts in Organisational and Institutional Studies (23 credits), the Research Essay (30 credit points) and 3 electives for a total of 69 credits. Admission requirements: A bachelor's degree or equivalent with a 68% or higher course mark aggregate in a third-year major.

MASTERS PROGRAMME

The Organisation and Institutional Studies (OIS) Masters Programme is intended for students who have either attended the OIS Honours Programme or come from other, related academic programmes and are interested in the study of institutions. This programme focuses on mastery of broader theoretical debates as well as the process of developing a research design and conducting their own research.

The Programme is made up of one advanced theory core course—Advanced Concepts in Organisational and Institutional Studies—and one methods and thesis development course, as well as electives. Students are required to submit a 20.000 to 25.000-word research essay.

All students must complete 180 credits, comprising of the course in Advanced Concepts in Organisational and Institutional Studies (30 credits), the Advanced Research Methods in Organisational and Institutional Studies, one elective course of 30 credit and a research report (90 credits). PHD PROGRAMME

The OIS PhD Programme is intended for students interested in contributing to the discipline through in-depth study and conducting independent and critical research.

We expect candidates to be theoretically driven and methodologically rigorous, and be able to conduct independent research of a high academic standard.

This is a 3 year programme and it is research only. However, we do encourage students to attend our research development seminars during the second semester.

Students will work closely with a supervisor to develop their proposals and to monitor their progress.
